WASHINGTON, Feb. 22, 2023 /PRNewswire/ -- Danaher Corporation (NYSE: DHR) announced today that its Board of Directors has approved a regular quarterly cash dividend of \$0.27 per share of its common stock, payable on April 28, 2023 to holders of record on March 31, 2023. In addition, the Board of Directors has approved a quarterly cash dividend of \$12.50 per share of its 5.00% Series B Mandatory Convertible Preferred Stock, payable on April 17, 2023 to holders of record on March 31, 2023.
